

# SEASON TICKET REGULATIONS

1. The season pass can be purchased by an adult of legal age, in compliance with the rental contract, which must be signed.
2. After signing the contract, for subsequent withdrawals it will be necessary to show only one identification document which must correspond to the holder of the subscription card.
3. You have the right to use your subscription to a second person other than the holder, provided that it is registered on the subscription contract at the time of purchase.
4. The purchase of a subscription entitles you to the use of both an e-trekking and an e-mtb;
5. For subscriptions purchased for minors, the document of the minor holder of the subscription and the document of the subscriber of the subscription must be presented; In the event that the minor is accompanied to the collection of the bicycle by an adult other than the subscriber of the subscription, this will only be possible if the companion has been previously registered in the rental contract as a person authorized by the subscriber, who remains responsible.
6. The subscription entitles you to the use of the bicycle for the number of 14 half days (HALF DAY), 5 full days (FULL DAY LIGHT) or 14 full days (FULL DAY GOLD) which we will hereinafter call "Window" in the case of one or "Windows" in the case of a number greater than one, until they are exhausted.
7. The use of the "Windows" can take place by booking it by sending an e-mail to the address [booking@funandbike.it](mailto:booking@funandbike.it), through the chat of the [www.funandbike.it](http://www.funandbike.it) website, through the social channels of FUN & BIKE, through telephone contacts; the use of the "Windows" can also take place without reservation by showing up directly at the store; in all cases the use of the "Windows" may be possible subject to availability of the bicycle covered by the subscription.
8. The reservation of one or more "Window" is binding; in case of non-collection of the bicycle, a "Window" will be considered used and therefore reduced from the remaining available ones.
9. Each "Window" is equivalent to the number of hours the store is open in the morning or afternoon (in the case of a FULL DAY LIGHT or FULL DAY GOLD subscription, it means the full day from the opening to the closing of the store); they vary according to the season and will be delivered to the Customer. If the "Window" is used for fewer hours than the maximum possible number, the "Window" is deemed to have been used.
10. The use of the "Windows" will be stored and updated both on the card given to the customer by perforating the "Window" and on the computer supports of FUN & BIKE DI SCIROCCO PAOLO which will have the only value in case of discrepancy with the customer's card which must be updated by FUN & BIKE.
11. Under no circumstances may the subscriber of the contract request the return of unused "Windows".
12. The use of the bikes rented with the subscription formula is regulated by the rental contract that the customer undertakes to sign.
